Audiologist wins award

Jaspreet Bahra, BSc (Hons) Audiology, RHAD, a senior audiologist at Harley Street Hearing in London, has been announced as the 2013 UK Audiologist of the Year. Jaspreet is the youngest winner to-date and the first audiology graduate to receive the accolade.

Jaspreet Bahra was delighted when she was told the news that she had won the Audiologist of the Year competition in the UK, "When I heard I had won such a prestigious award I was delighted. As an Audiologist you always try to help patients to the best of your ability. I felt both touched and honoured that my patient had taken the time to nominate me." After graduating with an honours degree in Audiology

from University College, London in 2007, Jaspreet spent two years working for a well-known national hearing aid company before joining Harley Street Hearing in 2009. the business has grown immensely and now has Paul Checkley as Clinical Director and a team of audiologists, a practice manager, marketing support and office staff. Paul Checkley also made the final shortlist of nominees but was pipped at the post by Jaspreet! Checkley said of his colleague, "When Jas joined us she was full of enthusiasm and keen to broaden her knowledge. She has since become a key member of the team who is liked by both her colleagues and her patients. I am delighted that she has received this recognition; she deserves it." The Audiologist of the Year competition, now in its sixth year, is run in partnership between Rayovac and Audio Infos Magazine and looks to celebrate the exceptional work of audiologists across Europe. Once again an independent judging process, which included a panel of the UK's industry professionals, took place during the summer months, to whittle down the nominees to determine the UK winner. Focusing on the dedication, commitment, knowledge and levels of care demonstrated by the audiologist, the judging panel had to grade the final shortlist of nine candidates on five different areas of expertise.

Commitment to her patients

Jaspreet was nominated by 29-year-old solicitor, Warren Stapley, whose inspiring story helped the judging panel make the decision to award her the UK's top hearing professional. The judges were greatly impressed by Jaspreet's dedication to her patient's well-being and commitment to ensuring Warren received state-of-the-art devices that have helped enhance his life in every aspect. Stapley's nomination ensured Jaspreet stood out from a record number of nominations this year. Alan Torbet, CEO of BSHAA and a member of the judging panel said, "I am delighted to have been involved in this year's Audiologist of the Year competition. This year has been a particularly strong year for entries and it truly is heart-warming to see the ways in which hearing professionals really can make such a difference to their patient's lives. Mr. Stapley's story shows the level of service he received from his

audiologist Ms. Bahra, and it is so inspiring to see that her support has helped him achieve his full potential making such a difference to his life."

After suffering from hearing loss since he was just six years old, Mr. Stapley explained how since meeting Jaspreet, his confidence has soared, with the new hearing aid devices he has been fitted with, making a real difference to his life. Supported by Jaspreet, Warren has faced up to the challenges of working in a competitive law environment whilst living with severe hearing loss. He was recently elected to the Executive Committee of the Lawyers with Disabilities Division, a division of the Law Society which seeks to widen access to the legal profession by creating a level playing field for talented disabled professionals and he credits a great part of his success to the invaluable support received from Jaspreet. In his nomination for Ms. Bahra, Warren said: "I have never known, nor even heard of, any audiologist being so committed to a patient that they would arrange appointments for the hours that Jaspreet does, even when it has meant rearranging their own annual leave. I cannot stress enough, having arranged for my primary care to be under Jaspreet and Harley Street Hearing, the difference this has made to my working

COUNTRY WINNERS

Hearing aid wearers have until July each year to nominate their dispenser for the award. Then an independent panel of judges in each country votes in August for their audiologist of the year.

EUROPEAN WINNER

Once the country winners have been chosen all of the independent judges across the six nations are asked to vote again to decide who the European champion will be. The winner is announced in October at the EUHA Congress.
